

BOARD OF SELECTMEN RECORD OF MEETING FEBRUARY 20, 2018 WINDSOR TOWN OFFICE

Members present: Rick Gray, Ray Bates, Dan Gordon & Ronnie Brann.

Employees Attending: Theresa Haskell (*Town Manager*), Tim Coston (*Transfer Station Supervisor*, Joyce Perry (*Cemetery Sexton*) and Debbie French (*Secretary to the Board*).

Richard Gray Jr. called the meeting to order at 6:05 p.m. with the Pledge of Allegiance.

Theresa introduced Blueberry and her Nana, April. Blueberry is 3 years old and has stage 4 neuroblastoma. She is allowed to have an experimental treatment in New York because regular chemotherapy is not working. Theresa asked the Board if they would consider having the Town Report dedicated to all of those in Town who have cancer or have family members with cancer. This was brought up to her by a Windsor Resident and believes this would be a good dedication.

Consideration of Warrants #35 and #36:

Ray Bates made a motion to approve Warrants # 35 and # 36 seconded by Dan Gordon and approved 4-0-0.

Town Manager's Items:

- a) 2018-2019 PSAP Contract which runs from July 1, 2018 to June 30, 2019 is up to \$17,133.00 which is up over 9% from last year. Ray Bates made a motion to authorize Theresa to sign the new PSAP Contract, seconded by Ronnie Brann and approved 4-0-0.
- b) Theresa said that there needs to be a write-off in the amount of \$217.80 which is the amount remaining from the Tax Sale Bid as of 2-13-18. Ray made a motion to approve the write-off in the amount of \$217.80 seconded by Ronnie Brann and approved 4-0-0 after much discussion.
- c) Theresa said the estimate to update the office computers is about \$7000.00 there was much discussion!

Selectmen's Items:

a) Ronnie would like to give consideration to building a lean-to at the PW Garage/Transfer Station to get the backhoe and sanders under cover and out of the sand shed which eats the equipment.
