

# BOARD OF SELECTMEN RECORD OF MEETING APRIL 5, 2016 WINDSOR TOWN OFFICE

## Ray Bates called the meeting to order at 6:01 p.m. with the Pledge of Allegiance.

### Public Meeting Regarding Transportation Issues in Windsor:

Kennebec Valley Council of Governments, at the request of Maine DOT, is studying transportation and development issues along the corridors between Augusta and the mid-coast. Chris Huck from KVCOG came and took public input on the transportation issues. There was much discussion and he will take all the suggestions/complaints to KVCOG & Maine DOT.

### **Previous Meeting Records:**

Dan Gordon made a motion to approve the Record of Meeting dated 3-22-16 with the correction of the Ballot Clerk vote of 4-0-0 which should have been 3-0-1 with Rick Gray, Jr. abstaining as his wife was one of the ballot clerks seconded by Rick Gray, Jr. and approved 4-0-1 with Jonathan abstaining as he was not at that meeting.

### Public Comment: None.

### Public Works:

- a) Keith said we need to get some more patch for some roads and he will just get what's needed right here in town from Auburn Asphalt. Keith said that the salt is doing pretty good and he will get a couple more loads and mix the sand & salt by hauling the sand himself.
- b) Ronnie asked when the road postings will be pulled. Keith would like to wait another week or two because of the cold weather and heavy rains we have been having. We also try to go along with the other towns with their postings.
- c) Several trees were down from the last heavy rain and wind in a few places but they have been taken care of.

# **Transfer Station:**

- a) Transfer Station report for March 2016: This report shows that we are down by \$1,110.10 from March of last year and a total of \$622.70 down from the total at this time last year.
- b) The bill from Daniels was for both the repairs of the binders and the new binders for the roll-off containers.
- c) Tim is interested in attending annual class in Rockland at the Samoset for a cost of \$275.00 on May 3<sup>rd</sup> and May 4<sup>th</sup>. Theresa said that Tim does learn a lot and makes good contacts at this annual meeting.

# Ray Bates made a motion to approve Tim to attend this annual meeting at a cost of \$275.00 for May 3, 2016 and May 4, 2016 seconded by Ronnie Brann and approved 5-0-0.

## Animal Control:

a) Beavers are back on Wingood Road! They will be taken care of by the Animal Damage Control (ADC) Officer, Tim Coston.

## **Town Manager's Items**:

a) Certificate of Appointments:

<u>Ray Bates made a motion to appoint the 7 Democratic and 7 Republican Ballot Clerks which were approved at the last BOS Meeting seconded by Ronnie Brann and approved 4-0-1 with Rick Gray, Jr. abstaining as his wife is one of the approved election clerks.</u>

- b) Theresa sent in a letter for a grant on signage which receipt of the letter has been confirmed. If approved they would pay 90% and we would only need to pay 10%.
- c) Hunts Meadow Road culvert: Theresa said they are discussing the process of the Hunts Meadow Road culvert replacement which would mean that the road would need to be closed during that time. Theresa said that she has spoken with the Town of Whitefield and DEP. She said that we will need to send this out to bid soon.
- d) Cemetery Rules: Much discussion. <u>Ray Bates made a motion to allow the Cemetery Committee to make the changes as stated seconded by Ronnie Brann and approved 3-0-2</u> with Dan Gordon abstaining as he doesn't think that the cemeteries need rules & Rick Gray, Jr. abstaining as he serves on that committee.
- e) KVCOG Household Waste Disposal Event: The BOS is not interested.
- f) MMA Workers Compensation Return Premium Adjustment:

Theresa said that she received the Workers' Compensation Audit back with a refund check \$781.00 which goes into Miscellaneous Revenue.

- g) Burgess Computer: Theresa said that we have some money in our Computer Reserve Fund this year for computers. Burgess is recommending that Theresa and Angela's computers be replaced and have the Windows 7 Professional Software installed. They also recommend changing from Dell Computers to Acer Computers. Theresa's laptop and Angela's computer will be replaced this year and the remaining ones in the office eventually. The BOS would like to get prices on Dell computers also.
- h) Spirit of America: There was discussion on who should be presented with this award this year.
- i) Town Report Front Cover & Dedication: Theresa asked for ideas.
- j) Greeley Road Culvert: Theresa said that she has been contacted by the Atlantic Salmon Federation regarding a possible grant for the Greeley Road Culvert. Theresa said Tom Squiers had done some major research in 2010 and is willing to help on this. The BOS was in agreement to send a letter to the Atlantic Salmon Federation welcoming their assistance to consider options in replacing or upgrading the Greeley Road Culvert. Rick Gray, Jr. helped Theresa with writing the letter of cooperation.
