

MINUTES OF WINDSOR EDUCATIONAL FOUNDATION AND REED FUND JANUARY 28, 2019 ANNUAL MEETING WINDSOR TOWN OFFICE

Ronald Brann called the Windsor Educational Foundation and Reed Fund Annual Meeting to order at 6:01 p.m.

<u>Ray Chavarie made a motion to approve the minutes dated April 9, 2018 and October 15, 2018 as</u> printed, seconded by Bonnie Squiers and approved 4-0-0.

<u>Ray Chavarie made a motion to appoint the above Board of Directors as listed and keep them the</u> same, seconded by Bonnie Squiers and approved 4-0-0.

Heather Wilson was planning on attending but had to be at the boys' basketball game tonight. She has sent over to me two requests. One is from Jana Diket, who looking for up to \$617.93 for aquarium equipment to lower the aquarium tank's temperature for an Intercoastal Habitat within the classroom and coolers for transporting. The second request is from Heather for her staff. She is requesting 35 wireless keyboards for the K-6 classrooms for a total cost of \$1,049.65. After much discussion, <u>Ronald Brann made a motion to approve up to \$600.00 for the aquarium equipment that Jana Diket was requesting and recommends getting the ½ HP Cooling System instead of the ¼ HP Cooling System because it is less expensive and more powerful, seconded by Bonnie Squires and approved 4-0-0. The second request from Heather Wilson was discussed to hold off on the key boards for now and see if this was asked through the original budget. Theresa had said Heather was hoping to be here at the meeting to present this her self but she evidently couldn't make it.</u>

Theresa said the next scheduled meeting will be April 8, 2019.
