The Select Board came out of executive session at 7:35 p.m. William Appel Jr., made a motion to accept the resignation letter from Kyoko Roderick, seconded by Richard H. Gray Jr. and approved 5-0-0. The Select Board and Town Manager would like to thank Kyoko Roderick for her 4 ½ years of dedication to the Town of Windsor. Theresa asked the Select Board to approve paying Kyoko Roderick her Banked PTO Time of 52.25 hours which can only be approved by the Select Board. Richard H. Gray Jr., made a motion to approve paying Kyoko Roderick her Bank PTO of 52.25 hours, seconded by William Appel Jr. and approved 5-0-0. With after discussion, William Appel Jr. made a motion to initiate a temporary stipend in the amount of \$750.00 per week to Theresa Haskell to cover the open position, seconded by Andrew Ballantyne and approved 4-0-1.
