

SELECT BOARD RECORD OF MEETING JANUARY 3, 2023 WINDSOR TOWN OFFICE

Members Present: Ray Bates, Ronald F. Brann, Richard H. Gray Jr., and Andrew Ballantyne. William Appel Jr. was absent.

Public Attending: Tom Reed and Moira Teekema.

Employees Attending: Keith Hall, (Road Supervisor) and Theresa L. Haskell (Town Manager).

Ray Bates opened with the Pledge of Allegiance at 6:00 p.m.

Previous Meeting Minutes: None at this time.

Public Works – Keith Hall said the following.

- a.) There was some brush that needed to be cleaned up from the wind storm. They removed trees out of the way as best they could.
- b.) Hunts Meadow Road tree trimming has now been completed.
- c.) There was an additional tree at the corner of the Hunts Meadow Road and Doyle Road that was taken down for an additional cost of \$400.00 and the owner of that property asked if he could have it and he would clean it up. The Hunts Meadow Road will need to have the shoulders cut down and some ditching will be done. We should also think about paving the inside corner at this intersection.
- d.) The culvert at the end of the Barton Road and Route 105 is filled and plugged with water running across the road. Keith said he will contact DOT.
- e.) The Weeks Mills Road brush cutting beginning at the Serenity Springs Trailer Park to the Barton Road has begun. Keith said they will also be going down the Barton Road.
- f.) They had to order a battery today for Truck #7. It is six years old.
- g.) Keith said the weather indicates freezing rain Wednesday into Thursday and may continue through Friday with snow/mix.

Transfer Station -

- a.) Theresa said Sean said he didn't have much to discuss tonight.
- b.) Theresa handed out the Monthly figures ending December 2022. The month of December 2022 was up from last year \$1,418.05 but we are still down (\$1,726.79) compared to the total last year at this time.
- c.) Moira said Sean indicated it was busy the past three days they were open.
