TOWN OF WINDSOR DUMP ORDINANCE

ADOPTED SPECIAL TOWN MEETING, December 10, 1975 AMENDED, March 9, 1987

TOWN OF WINDSOR DUMP ORDINANCE

The following ordinance is enacted pursuant to Title 30, Section 3151 and 2153.

- 1. No person shall dump solid waste within the Town of Windsor except at the Municipal Dump
- 2. No person except residents an seasonal residents shall dump solid waste at the Municipal Dump
- 3. Anyone violating the provisions of this ordinance shall be subject to a fine of fifty dollars (\$50.00). Each violation of said ordinance shall be considered a separate offense.

- Article 47: Upon motion duly made and seconded voted to RAISE \$1,000.00 for purchasing two radios for use with town equipment.
- Article 48: Upon motion duly made and seconded voted YES to accept changes to the Shoreland Zoning Ordinance to conform to State minimum Shoreland Zoning Ordinance amendmends since 1979.
- Article 49: Upon motion duly made and seconded voted YES to accept changes to both the Shoreland Zoning Ordinance and the subdivision ordinance which became State law with the 1983 Rivers Act.
- Article 50: Upon motion duly made and seconded voted YES to raise the fine for illegal trash dumping at the Town Dump from Fifteen Dollars (\$15.00) to Fifty Dollars (\$50.00) effective March 9, 1987.
- Article 51: Upon motion duly made and seconded voted YES to earmark the Snowmobile Registration Tax Refund from the Department of Fisheries and Game to be used as a Snowmobile-Recreation Fund. 50% to be used for snow-mobiles and 50% to be used for other recreation. Expenditures from these funds to be administered under the supervision of the Board of Selectmen.
- Article 52: Upon motion duly made and seconded voted to allow 2% discount on taxes paid in full or in part within 30 days after tax billing date.
- Article 53: Upon motion duly made and seconded voted YES to charge interest and at the rate of 3/4% per month (9% per year) on taxes paid in full or in part after November 30, 1987.
- Article 54: Upon motion duly made and seconded voted YES to authorize the Selectmen to accept money or legacy in trust for the benefit of Publis Ceneteries or lots therein.
- Article 55: Upon motion duly made and seconded voted YES to authorize the Selectmen to sell lots on such terms as they deem advisable, and execute deeds for same, in Town-Owned Cemeteries.
- Article 56: Upon motion duly made and seconded voted YES to authorize the Selectmen to procure a temporary loan or loans within the 1987 taxable year in anticipation of taxes for the purpose of paying obligations of the Town. Such loans to be paid within the taxable year.
- Article 57: Upon motion duly made and seconded voted YES to authorize the Selectmen on behalf of the Town to sell and dispose of any real estate acquired by the Town for non-payment of taxes thereon. Property to be sold shall be listed in the annual town report and posted in four (4) public places in the Town for a period of one week beginning on May 1. However, upon expiration of a tax lien, subject tax-acquired property may be redeemed by the previous owner before the May 1st bid notice, or the property may be kept and maintained by the Town should the Selectmen decide this to be more advantageous. The Selectmen shall have the authority to accept a payment plan of monthly payments. If a payment is in default for one month, said property shall revert to the Town for sale.
