## **Key Messages**

- FEMA has approved \$3,323,232 to help individuals and families in Androscoggin, Franklin, Kennebec, Oxford and Somerset counties recover from the December 17-21, 2023 severe storm and flooding.
- Assistance may include grants for temporary housing, uninsured or underinsured home repairs and personal property, low-cost loans to cover uninsured property losses, and other programs to help individuals and business owners recover from the disaster.
- 10 Disaster Survivor Assistance crews have canvassed in Leeds, Wales, Lewiston, Turner, Peru, Woodstock, Paris, Hanover, Canton, Newry, Milton Township, Oxford, Waterford, Dixfield, Fryeburg, Sumner, West Paris, Otisfield, Gilead, Greenwood, Lincoln Plantation, Byron, Hartford, Stoneham, Lovell, Chesterville, Salem, Fairfield, Madison, New Portland, Smithfield, Athens, Mercer, Monmouth, Vassalboro, Oakland, Belgrade, Mount Vernon, West Gardiner, Readfield, Manchester and Pittston.
- To date, 1,608 survivors have applied for FEMA assistance.

#### **Disaster Recovery Centers**

Disaster Recovery Centers provide information from Maine state agencies, FEMA and the U.S. Small Business Administration. Survivors can visit to get help applying for federal assistance, update applications and learn about available resources.

Centers are now open 9 a.m. to 5 p.m. Monday through Saturday at:

#### **How to Apply for FEMA Assistance**

To apply for FEMA assistance:



- Visit <u>DisasterAssistance.gov</u>;
- Download the FEMA App; or,
- Call 1-800-621-3362. Help is available in most languages. If you use video relay service (VRS), captioned telephone service or another relay service, give FEMA your number for that service when you call. Phone lines operate from 7 a.m. to 11 p.m. seven days a week.
- The deadline to apply for FEMA assistance is April 1.
- When you apply, have the following information ready:
  - The Social Security number for the head of household/applicant and any co-applicant;
  - The address and phone number where you are staying; and,
  - A description of damage to your home.
- Be sure to share updates with FEMA so we can continue to review your case.

### **Disaster Unemployment Assistance**

- Employees or self-employed individuals in Maine who became unemployed as a direct result of this severe storm and flooding may be eligible for Disaster Unemployment Assistance (DUA).
- To be eligible for DUA, the individual must be determined ineligible for regular unemployment insurance benefits under any state or federal law. Claimants must first apply for state unemployment benefits by visiting Maine Department of Labor's Bureau of Unemployment Insurance self-service portal.
- An application must be submitted by March 4, 2024. Claims filed after this deadline may be ineligible.
- Those eligible for DUA are encouraged to also apply for federal assistance.

#### **U.S. Small Business Administration (SBA)**

SBA disaster loans are the largest source of federal disaster recovery funds for survivors. Businesses, homeowners, renters, and certain nonprofits that were affected may apply online for low-interest disaster loans using SBA's secure website at DisasterLoanAssistance.sba.gov/ela/s/. Applicants may also call SBA's Customer Service Center at 800-659-2955 or email DisasterCustomerService@sba.gov for more information. Individuals who are deaf or hard-of-hearing may call 800-877-8339.
